Purpose: The donation shall be generally used by the Little Chute Area School District for the construction of a new synthetic multi-purpose athletic field, for the public purposes of providing students and community members a space to participate in and promote the educational and charitable opportunities and growth found in youth athletics and the promotion of public health through physical activity.

AGREEMENT made between the above-named Donor and the Little Chute Area School District, which is an agent of the State of Wisconsin created for the purpose of administering the state's system of public education, hereinafter called the "School District."

WHEREAS, the School District likely qualifies as a governmental unit under 26 U.S.C. § 170(c)(1); the School District desires to build a new synthetic multi-purpose athletic field which would include, but is not limited to, a football field and soccer field at Little Chute High School, for the public purposes of providing students and community members a space to participate in and promote the educational and charitable opportunities and growth found in youth athletics and the promotion of public health through physical activity (the "Project"), and is raising funds by means of contributions from private as well as public sources; the School District's financial ability to pay for said construction will come primarily from these contributions; Donor desires to support the School District's efforts by making contributions to the School District as set forth above; and the School District may rely upon the above contributions and may use this donation to obtain financing for said additional facilities;

NOW THEREFORE, in consideration of the foregoing, and to induce the School District to proceed with the additional facilities.

DONOR HEREBY PLEDGES and agrees to give, donate, contribute, transfer, and deliver to the School District the Donation set forth above, which shall be payable as set forth above, as a contribution and gift to the School District to be used for the Purpose set forth above. This donation is a legal obligation of the Donor (and each of them jointly and severally if there are more than one) and of the Donor's heirs, successors, legal representatives, and assigns. Donor acknowledges that the School District relies upon this donation in a substantial manner in furtherance of its charitable purposes and that the School District is incurring substantial liabilities in so relying and will suffer material detriment if this donation is not honored. Therefore, this pledge is valid and enforceable and may not be revoked or rescinded without the School District's written consent. This donation is governed by the laws of Wisconsin.

DONOR HEREBY AGREES to not make any public announcement, press release, disclose any information or details regarding the Project prior to the School District securing donations.

Contributions to the School District should be tax deductible under 26 U.S.C. § 170(b)(1)(A)(v) to the extent allowed by law from time to time.
